- (ii) 'appointment as Assistant Professor and admission to Ph.D.'
- (iii) 'admission to Ph.D. only' in Indian universities and colleges.

No corrections will be accepted after 12 November 2025 (11:50 P.M.) under any circumstances. The additional fee (if applicable) shall be paid by the candidate concerned through Credit/Debit Card, Net Banking, or UPI only.

This facility is extended only once to avoid any hardship to the candidates. Therefore, candidates are advised to make corrections carefully, as no further opportunity for correction will be provided.
